



## Clear Bag Policy for Special Events

### Introduction:

This policy aims to ensure that “safety” is at the forefront of the environment we cultivate at our arena during all special events. It also aims to deter objects (that could be used as weapons or act as a health or safety hazard) from entering the arena undetected, so that all persons inside the arena are able to enjoy an event without the worry about their safety.

### Policy Statement:

The goal of this policy is to provide a safer environment for the public and significantly expedite attendee entry into all TC Facilities including but not limited to 10441 S. Regal Blvd., Tulsa, Oklahoma 74133 and 1519 W. Pine St., Tulsa, Oklahoma 74127. To accomplish this goal, Transformation Church has implemented a “clear bag” policy for all special events that limit the size and type of bags that can be brought inside the facilities. Transformation Church strongly encourages attendees not to bring any bags during special events.

### Approved for Entry:

Attendees will be able to carry the following style and size bag, package, or container at arena plaza areas, arena gates, or when approaching queue lines for attendees awaiting entry into the arena:

- Bags that
  - ◆ Are all clear; and
  - ◆ Are plastic, vinyl, or PVC; and
  - ◆ Do not exceed 12” x 12” x 6”; and
  - ◆ Do not have buckles, grommets/hardware, or décor that can conceal any bag part.

Transformation Church **MAY** have clear bags for attendees to acquire during special events.

### Approved with Inspection:

The following bags will be allowed after an on-site and in person inspection:

- Necessary medical bags

### Prohibited Items:

Prohibited items include but are not limited to:

- Purses more significant than a clutch bag
- Coolers
- Briefcases
- Backpacks
- Fanny packs

- Diaper bags
- Cinch bags
- Luggage of any kind
- Computer bags
- Camera bags OR
- Any bag more extensive than the permissible size.

**Attendees Traveling / Using Public Transportation:**

If an attendee is using public transportation (i.e., Uber, Lyft) to and from the facilities, they must make sure that what they are carrying on their person can fit inside the dimensions of the clear bag. Transformation Church will not be, under any circumstances, responsible for an attendee's belongings who have used public transportation but carrying a prohibited bag type and one that does not fall under the exceptions explained within this policy. **Transformation Church will not have a designated area for any luggage brought to the facilities – all luggage is prohibited.**

**Violation of Policy:**

Violation of this clear-bag policy could result in the prevention of entry into the arena. If the clear-bag policy were mistakenly overlooked, the attendee would have the opportunity to return their belongings to their vehicle to ensure access. **Transformation Church reserves the right to prevent entry for any attendee who fails to adhere to this policy in its entirety.**
